Generally, the editing functions you are trying to do can fail terribly. Acrobat is not really an editing environment and the tools are not easy to use even for minor editing. A lot is based on the structure of the PDF and how things are grouped (objects). You can move an object, but not parts of it.

If the PDF worked BEFORE the MOVE, COPY, or RENAME, it should work AFTER the move, copy, or rename. However, we have seen where if AFTER the MOVE that you cannot OPEN the PDF with Adobe (or move or copy the file to a new location) that perhaps your NEW PDF File name and DATA PATH structure is not well under 255 characters .

## **(Solved) - Can't delete or move certain pdf files! – How**

It's possible that these PDF files are PDF/A compliant -- you can check this by opening the Standards Navigation panel. If so, then you'll need to turn off the following preference before you can rearrange pages: Edit > Preferences > Documents Categories and select "Never" from the View documents in PDF/A mode.
